

Directions to CASA—Mercer and Burlington Offices

CASA of Mercer County: 1450 Parkside Ave., Suite 22, Ewing, NJ 08638

From Rt. 206 (Princeton and Northern areas): Take Rt. 206 South into Lawrenceville. Pass Rider University. Make right at light onto Eggerts Crossing Rd. Take Eggerts Crossing Rd. to the end. Make a left onto Ewingville Rd. Continue down Ewingville Rd which becomes Parkside Ave. – Professional Park on left hand side of road .

From Rt. 95/295 (Hamilton, Lawrenceville): Take Rt. 295 North/95 South. Get off at Exit 5A (Federal City Road South). Take Federal City Road to end. Make a left onto Ewingville Road. Continue down Ewingville Rd. which becomes Parkside Ave. – Professional Park on left hand side of road.

From Garden State Parkway, I-195: Take the New Jersey Garden State Parkway to Rt. 195 West.

Exit at Rt. 295 North. Take Rt. 295 and exit at Rt. 206 South. Make right at 2nd light on Eggerts Crossing Rd. Take Eggerts Crossing Rd. to the end. Make a left onto Ewingville Rd. Continue down Ewingville Rd which becomes Parkside Ave. – Professional Park on left hand side of road 1450 Parkside Ave. Suite 22

From New Jersey Turnpike: Take the NJ Turnpike to exit 7A (Rt. 195 West). Take Rt. 195 to exit for Rt. 295 North. Take Rt. 295 to exit for Route 206 South. Take Rt. 206 South. Make right at 2nd light on Eggerts Crossing Rd. Take Eggerts Crossing Rd. to the end. Make a left onto Ewingville Road. Continue down Ewingville Rd which becomes Parkside Ave. – Professional Park on left hand side of road.

From Route 1: Take Business Rt. 1 South to Brunswick Circle. Take 2nd right off circle. Follow to merge w/Princeton Ave. to Spruce St. (2nd light) Turn right on Spruce Street and follow "T". Turn left onto Ewingville Rd. Continue down Ewingville Rd which becomes Parkside Ave. – Professional Park on left hand side of road

From Olden Avenue: Proceed East on Parkside Ave. We are on right hand side of road Professional Park 1450 Parkside.

CASA of Burlington County: 137 High Street Suite 1-C, Mt. Holly, NJ 08060

Coming from the South, via Interstate 295 North: Take exit 45A towards MT HOLLY. Merge onto Rancocas Rd and continue on Rancocas Rd for about 3.4 miles. Turn left onto High St. 137 High St will be on your right.

Coming from the North, via Interstate 295 South: Merge onto CR-541 S via exit 47A towards NJ TURNPIKE/MT HOLLY for 3.6 miles. CR-541 S becomes High St. 137 High St will be on your left.

Coming from the NJ Turnpike: Take exit 5 towards BURLINGTON/MT HOLLY. Stay straight to go onto ramp. Turn right onto Burlington Mt Holly Rd/CR-541 S. Continue to follow CR-541 S. CR-541 S becomes High St, and 137 High St will be on your left.

>>Landmark: Burlington Office is located across from the old courthouse and Prison Museum near the corner of High and Union Street.
